### Wake Correctional Center Volunteer Opportunities

#### **Onsite Activities:**

**Religious Activities:** A variety of onsite religious activities are currently held on a regular basis. These include, but not limited to, Bible Study, Lay Ministry, gospel presentations, church services, Yokefellow Prison Ministry, Islamic Services, Sunday School and others. Please specify the name of the religious group you will be volunteering with

**Education Activities:** Assistance in tutoring inmates involved in GED or Adult Basic Education (ABE) classes, reading program, etc.

**Individual Counseling:** Working one-on-one with an Inmate to share information, a skill or interest that may better equip him for re-entry into society upon his release. Serve as mentor and role model.

**Substance Abuse Counseling:** Attend and assist in obtaining outside speakers for AA/NA programs that meet weekly.

**Resource Agent:** As a member of our Community Resource Council (CRC) you will act as liaison between Wake Correctional Center and the community who can provide direct services to inmates and staff.

#### **Offsite Activities: (Must serve as an Onsite Community Volunteer first)**

**Individual Sponsorship:** You will serve as mentor and role model. A CV Sponsor may escort an eligible inmate into the community. An inmate may participate in the program three times per week (Sunday through Saturday) for as many as six hours per visit. The CV Sponsor may take the Inmate to church services, the library, AA or NA meetings, other community events. As CV Sponsor may also have the Inmate as a houseguest (only once a month) or take them to a restaurant if they so choose. **The first time you take an Inmate out during the Sunday through Saturday time frame, you must take him to a church service, the library, and AA or NA meetings.**
